

Legislative Wrap

17th Lok Sabha (2019-2024)

The final session of the 17th Lok Sabha ended on February 10, 2024. During the term of the 17th Lok Sabha, Parliament passed 221 Bills – 42 Bills related to budgets, and 179 other Bills. At the end of this period, 20 Bills remain pending in Rajya Sabha. Four Bills will lapse on the dissolution of Lok Sabha. One of these Bills have been passed by one House.
